

VISITOR'S ACKNOWLEDGMENT OF RISKS

In consideration of the services of Raft Moab, Inc., DBA WORLD WIDE RIVER EXPEDITIONS, their officers, agents, employees, stockholders, sponsors, and all other persons or entities associated with those businesses (hereinafter collectively referred to as "WWRE"), I agree as follows:

Although WWRE has taken reasonable steps to provide me with appropriate equipment and skilled guides so I can enjoy an activity for which I may not be skilled, WWRE has informed me this activity is not without risk. Certain risks are inherent in each activity and cannot be eliminated without destroying the unique character of the activity. The same elements that contribute to the unique character of this activity can be causes of loss of, or damage to my equipment, accidental injury or illness or, in extreme cases, permanent trauma or death. WWRE does not want to frighten me or reduce my enthusiasm for this activity, but WWRE does think it is important for me to know in advance what to expect and to be informed of the inherent risks. The following describes some, but not all, of those risks:

Whitewater rapids will be encountered. I can be jolted, jarred, bounced, thrown and shaken about during rides through some of these rapids. It is possible that I could be injured if I come in contact with food boxes, other storage containers, or other fixed equipment necessary to the operation of the expedition and the outfitting of the raft. Injuries and property loss could also occur due to raft to raft water fighting. Rafts could turn over or I could be "washed" overboard. I can slip or fall during a hike, resulting in damage to equipment or personal injury. Accidents can occur getting on and off the raft. Rafts are slippery when wet. Exposure to the natural elements can be uncomfortable and/or harmful. I am aware that this exposure could cause sunburn, dehydration, heat exhaustion, heat stroke, and heat cramps. Also prolonged exposure to cold water can result in hypothermia, and in extreme cases death and accidental drowning is also a possibility.

I am aware that river rafting and associated activities entails risks of injury or death to any participant. I understand that the description of these inherent risks is not complete and that other unknown or unanticipated risks may result in injury or death. I agree to assume and accept full responsibility for the inherent risks identified herein and those risks not specifically identified. My participation in this activity is purely voluntary, no one is forcing me to participate, and I elect to participate in spite of and with full knowledge of those inherent risks.

I acknowledge that engaging in this activity may require a degree of skill and knowledge different than other activities and that I have responsibilities as a participant. I acknowledge that the staff of WWRE has been available to more fully explain to me the nature and physical demands of this activity and the inherent risks, hazards, and dangers associated with this activity.

I certify that I am fully capable of participating in this activity. Therefore, I assume and accept full responsibility for myself, including all minor children in my care, custody and control, for bodily injury, death, and loss of personal property and expenses as a result of those inherent risks and dangers identified herein and those risks and dangers not specifically identified, and, as a result of my negligence in participating in this activity.

I have read, understood, and accepted the terms and conditions stated herein and acknowledge that this agreement shall be effective and binding upon myself, my heirs, assigns, personal representative, estate and for all members of my family, including minor children. I acknowledge I am not relying on any oral, written, or visual representations or statements made by WWRE including those made in its brochures or other promotional material, to induce me to participate in this activity.

WWRE reserves the right to take photographic or film records of any WWRE's trip, and each trip member hereby agrees that WWRE may use such photographic or film records for promotional and/or commercial purposes.
